



Why the award was given:

Aquathin Corp. received the "E" Award for its performance in exporting its water purification systems worldwide since 1984. In the last two years, the family-owned company's exports accounted for up to 65% of its total sales. Company executives declined to discuss specific sales and export figures.

Company Data:

Chief executive: Alfred Lipshultz, president.

Headquarters: Fort Lauderdale, Fla.

Employees and plants: Aquathin currently employs 16 people in all of the company's departments at Fort

Lauderdale. In response to continuing growth, the company recently moved into a 60,000 square foot facility known as the Aquathin Business Center.

Aquathin's new headquarters include manufacturing and assembly facilities, sales, shipping, corporate offices and distributor education center known as the Aquathin University. The company takes up one third of the entire facility and rents out the rest.

Basic business: Aquathin designs and manufactures purification systems to produce water "free of salt, heavy metals, water borne disease-causing micro-organisms, industrial pollutants and pesticides," the company claims.

Aquathin offers a variety of patented reverse osmosis and deionization (RO/DI) products developed to purify common tap, well and brackish water for residential, commercial and industrial use. These products include the portable new Kitchentop model and the patented "Platinum 90," a compact system combining Aquathin's patented RO/DI process, a granular activated carbon filter, the patented Elec-

tronic Memory Panel for automatic maintenance, and the patented "Cairfreegap" faucet. The company also manufactures trademarked softeners, charcoal filters, iron filters and lead removal systems.

Reason for Exporting:

Aquathin was established in 1980 in the wake of concern over the quality of drinking water in the United States. As that concern spread worldwide, so did opportunities for the company's products in foreign markets. Initial attempts to enter the world markets via U.S.-based import/export agents were so unsuccessful that the company dropped its export program altogether, according to Aquathin's president, Alfred Lipshultz. "I put my blinders on with total disregard for anything having to do with export," said Mr. Lipshultz. "Our goal was to develop a foothold in our backyard."

Interest in exports was rekindled in 1984 when Mr. Lipshultz participated in a seminar on exporting. "What a breath of fresh air," reflected Mr. Lipshultz, who, at the seminar, learned of the U.S. Department of Commerce's "diligent effort to reduce the U.S. trade deficit through promoting quality U.S. companies."

Export Success:

Subsequent participation in the various export programs sponsored by Commerce helped Aquathin expand its domestic as well as overseas markets. Both grew tremendously. The increase in exports, which accounted for about 60% in 1991, accompanied growth in domestic sales, Mr. Lipshultz said.

Commerce's led to contacts for a network of distributors that Aquathin needed to venture into foreign markets. For instance, Aquathin became a part of the computer information system at all U.S. embassies for a source of water treatment equipment of interest to potential foreign agents and distributors. Commerce's trade missions also helped the company meet local government and business leaders in foreign markets.

Distributors have contributed tremendously to the success of Aquathin. Aquathin invites them to fly to Fort Lauderdale at the company's expense to take part in a three-day training program at Aquathin University, the corporate training center. The distributors receive one-on-one attention and "become involved in the production, sales and the education of our philosophy," Mr. Lipshultz said.

Today, Aquathin sells its systems through 525

distributors, most of whom are located inside the United States. Aquathin has one or two distributors in each of its overseas markets.

"We want to maintain loyal family members," he said. Each distributor maintains direct contact with the corporate headquarters.

Acknowledging that the arrangement of having two agents a country at most might not encourage competitiveness, he said "we do not want our distributors to undercut one another, either."

Markets:

Aquathin's overseas markets include Canada, Latin America, Europe and the Far East. The company has put on hold a plan to set up a shop in Ireland to better serve its European customers because of a lack of unification of regulatory framework and other market conditions, Mr. Lipshultz said.

Meanwhile, orders from Latin America have risen sharply, he said. "Latin America is going to be the No. 1 market for us in 1992," he said.

Transportation:

Aquathin used both air and ocean freight to ship its products.

The Aquathin Corp. Story:

When Aquathin Corp. was established in March 1980, it sought to supply its system (only one specific unit type at the time) to a group of physicians who were interested in providing services to patients seeking "guidance for problems of obesity and/or enhanced longevity."

Soon, the company ran into immense problems from "inept marketing to manufacturing," failure of some physicians to honor their agreement with the company, and lack of aggressiveness on the part of a partner.

Sales in the second year plummeted to \$39,000 from \$74,000 in the first year of founding.


Realizing the company would fail if something drastic was not done, Mr. Lipshultz, then vice president, and his father Mitchell Lipshultz, bought out the partner and cut ties with its marketer. The company became family-owned.

The younger Mr. Lipshultz redesigned the equipment and began advertising in trade journals. Domestic sales subsequently began to grow and a network of domestic distributors came into being.


Back to basics: Aquathin Corp. wants water to be just that, plain H,O.

The Pompano Beach-based company, founded in 1980, manufactures and distributes purification systems that free water of salt, minerals and pollutants. Its best sellers are residential drinking systems that cost between \$450 and \$900. The company also targets offices and businesses. It offers 58 systems at prices ranging from \$49 to \$40,000.

President Alfred Lipshultz would not disclose the company's sales figures. But he said sales have grown by about 20 percent a year since it started until

1990. Recessionary trends last year slowed the company's growth to about 13 percent, he said.

Lipshultz said Aquathin built its clientele through word-of-mouth recommendations. The company gradually developed an international network of 500 distributors. The company recruits them by placing ads in trade publications and trains them in three days.



Aquathin receives a patent for water-purifying device

QUATHIN Corp.. the Fort Lauderdale-based manufacturer of water purification systems, has received a patent for an electronic memory panel, a feature that prolongs life and efficiency of a reverse-osmosis element.

The electronic memory panel allows a reverse-osmosis system to manufacture purified water, then shut down and depressurize. This is expected to reduce maintenance and increase the efficiency and longevity of the reverse-osmosis element.

The 10-year-old company designs and manufactures 57 different water-purification systems for commercial and residential use. The company also holds the patent for the only reverse osmosis/deionization purification system on the market, producing water free of salts, heavy metals and chemical pollutants.

In April, Aquathin received the President's "E" Award from the U.S. Department of Commerce for excellence in exporting.

U.S. honors four S. Florida firms for exports

Four South Florida manufacturers are being recognized for their contributions to improving the nation's balance of trade.

At a ceremony at the Inter-Continental Hotel in Miami on Friday, officials from the U.S. Department of Commerce will bestow their "E" award to personal computing firms Boca Research and Core international of Boca Raton, Gribetz International in Sunrise. which manufactures machinery used to make quilting for mattresses, and Aquathin in Fort Lauderdale, which makes reverse osmosis water treatment equipment, also will be honored.

They were the only Florida companies given the honor this year, said Ivan Cosimi, director of the U.S. Department of Commerce's Miami district office.

The "E." or export, award is designed to recognize companies for success in exporting. Since its inception 29 years ago, the award has been given to 74 Florida companies.

Five-year-old Boca Research designs and manufactures printed circuit boards that can be plugged into IBM compatible personal computers to expand the jobs they can do. The private company does not release dollar sales figures, but it has increased its exports from 7 percent of sales in 1987 to 28.7 percent as of February, said Sylvia Fagiani, a spokesman for the company.

The 60-employee firm expanded its advertising in the European edition of BYTE magazine last year and has ridden its 100,000 circulation in Europe to higher mail order and distributor sales.

Core International is a premier supplier of high performance disk drives and other mass storage devices for IBM compatible personal computer networks. The company's exports rose from 3 percent of sales in 1985 to 25 percent in 1989, said Theresa Marcous, director of international sales.

Most of the sales were in Europe, Australia and New Zealand, Marcous said.

Aquathin Distributing designs, many factures and distributes 57 variations of its reverse osmosis water treatment system in mostly industrialized countries in Europe and the Pacific Rim. Exports have grown from 8 percent of sales in 1987 to 59 percent in 1989, said Alfred Lipshultz president

Gribetz International, with about 120 employees, manufactures quilting machinery in the Sawgrass International Corporate Park in Sunrise. The company exports its product to 40 countries. International sales increased about 20 percent this year and now make up about 40 percent of the firm's total sales, said Steven Fayne, chief financial officer and general counsel.



I'm pleased to inform you that today we finished the installation of the water purification system at th US Embassy in San Jose, Costa Rica, consisting on the following equipment supplied by AQUATHIN:

Two sets of stainless steel 50-10 micron sediment prefiters + flow meter with programmable divider + calcium hypochlorite feed pump + calcuim hypochlorite tank agitator + zinc orthophosphate feed pump + static mixer.

US Embassy personnel was pretty excited about the job done and they took a water sample for pre-testing. Calcium hypochlorite was set to 1 ppm and zinc orthophospate was set to 5 ppm. If the result of the test if good, their water cisterns main valve will be opened and will have treated water on the embassy bulding. Later adjustments will be done according to chlorine samples taken from different faucets on the building.

I want to thank you for all the prompt assistance you gave to us in all the steps involved with this installation. Also, please extend our thanks to the OEM technicians who gave us the necesarry infomation on the equipments and chemicals.
